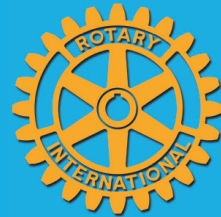

INDIVIDUAL	One who has been elected to and enjoys all obligations, responsibilities under a business or professional classification and privilege of membership as provided in the RI Constitution and Bylaws. Active (Individual) members may hold office in their club and service RI at the district and international levels. They are expected to meet attendance, pay dues and bring new members into Rotary.	\$200
ASSOCIATE	A program to recruit younger members to membership. Associate Membership is available to anyone who is proposed for membership who is 40 years of age or less and will end when member reaches one year past their fortieth (40th) birthday. After that date, dues will invert to Individual Membership.	Current RI and District Dues
HONORARY	Honorary members are exempt from club dues. Entitled to attend all meetings and enjoy other privileges in the club, but have no voting rights.	\$0
FAMILY	A spouse, significant other, son or daughter may join as a family membership. Dues for the primary member is the same as an Individual Membership with additional family members paying at a significant reduction (Current RI and District Dues).	\$200
FRIENDSHIP	Friendship Membership is designed for members who are interested in helping the club and taking part in projects, but who cannot commit to meetings.	\$125
CORPORATE	Corporate Membership is a program to allow multiple employees of a business Rotary participation under one primary membership.	\$250
